Notice

As per the Notice cited under reference No 1.the Extension Round III Merit list is to be declared on 15th April 2021, and the colleges are to admit the candidates from 16th to 19th April 2021 on working days only.

Due to Advisory “Break the Chain” (Reference No.2.) issued by Government of Maharashtra on 13th April 2021, the following instructions are being shared with all the admitting colleges.

In view of the strict restrictions in the Government circular “Break The Chain” in all cases college should avoid calling the candidates to the colleges for documents verification & admission purpose.

The colleges should verify the documents/credentials through Video Conferencing/ E-Mails/What’s App.

On verification, the candidate should pay the seat acceptance fee of Rs. 1000/- through College login, if candidate has not paid the Seat Acceptance fees in any previous round online through candidate’s login. Colleges are prohibited from accepting the Seat Acceptance fees again if it is already paid by the candidate through his login.

On payment of the Seat acceptance fee, college should confirm the admissions.
Colleges are liberty to seek written undertaking from the Candidates.

The colleges can do the physical verification of the documents after the restrictions are eased.

Regarding College fee payment, you can give time to candidates or ask the candidate to deposit in the bank or if the college has any other online fee payment facility they can use that.

The colleges strictly warned not to call the candidates in the college premises.

It is obligatory on the part of the admitting College to intimate the process of admission to the candidates in the Merit List, via E-mail & SMS both ways.

Making Online Admission facilities available to the candidates is the responsibility of the admitting colleges. Communicating On line process of the admission to all the candidates who have given choice/s is also the responsibility of the all colleges.

This extension round has been recommended by DHE as per the demands of Organizations mentioned in the Notice of 08/04/2021.

No extension to this round will be given in any case.
